Criminal Record Screening

Consistent with provincial policy for all health sciences students in post-secondary education experiential learning, all applicants offered admission to the MPT program at the School of Rehabilitation Science will be required to submit a "Criminal Record Check" (CRC), including "Vulnerable Sector Screening" (VSS) as a requirement for acceptance to the MPT program and following acceptance to the program. As an initial screen of applicants and to permit time for additional information seeking where necessary, applicants are requested to answer the following screening questions. Note: you are NOT being asked for the official CRC at this time. The information you provide to the questions below will be kept in a highly secure and confidential manner. - **January 21** Deadline for Term 1 transcripts and Final transcripts (if you have completed a degree). As well, other required documentation specified on the checklist is to be received directly at the School of Physical Therapy, University of Saskatchewan, 104 Clinic Place, Saskatoon, SK S7N 2Z4.
- **Mid-February** Letters are emailed to applicants selected to attend the MMI interviews.
- **2nd weekend in March** MMI interviews.
- **By mid-April** Notification of admission results will be emailed
- **June 7** Deadline for final transcripts showing all final grades and THE AWARDING OF THE DEGREE (applicable to those offered admission and to those on the reserve list).
- **1st week of June** Registration packages mailed to incoming students.
- **1st week of July** Deadline to register for MPT courses for fall/winter/spring/summer.
- **Mid-August** MPT program begins.
