COLLEGE OF MEDICINE APPLICANT CONDUCT AGREEMENT

The University of Saskatchewan College of Medicine (CoM) Faculty is committed to upholding the highest standards of ethical and professional behaviour. Consequently, all interviewed applicants to the CoM will be required to read and sign this applicant conduct agreement.

Your signature confirms and acknowledges:

- (i) your registration to take part in the CoM's interview process for admission to the college.
- (ii) your agreement to not disclose the identity of the assessors/interviewers, information about the interview process, or station information, and to not disclose any of the questions and answers made during your interview (may include Multiple Mini Interview/Panel Interview/Conversation Circle). This information is strictly confidential and shall not be disclosed to any person. An applicant found to be disclosing any aspect of the interview process, station information, or interview questions will be reported to and reviewed by the Professionalism and Areas of Concern Committee and could result in your application being stopped on these grounds. This obligation of confidentiality extends beyond the application process and remains in force for a period of ten (10) years after the end of the current application cycle. If admitted to the program, identified breaches of this agreement will be addressed through MD program professionalism procedures.
- (iii) your agreement to not record (electronically or otherwise) any aspect of the interview process, including the station information, interview questions, or interaction between applicant and assessor/interviewer. An applicant found to be recording any aspect of the interview process, station information, interview questions or interaction between the applicant and assessor/interviewer will be reported to and reviewed by the Professionalism and Areas of Concern Committee and could result in your application being stopped on these grounds. If admitted to the program, identified breaches of this agreement will be addressed through MD program professionalism procedures.
- (iv) your agreement that it is strictly prohibited to bring into the interview notes or reference materials of any kind. Applicants will not be permitted to take notes or access any electronic or physical reference materials during their interview. An applicant found to be accessing notes or reference materials during their interview will be reported to and reviewed by the Professionalism and Areas of Concern Committee and could result in your application being stopped on these grounds. If admitted to the program, identified breaches of this agreement will be addressed through MD program professionalism procedures.
- (v) your agreement that the use of Artificial Intelligence (AI) during the interview process or while preparing a response to an interview station/question is strictly prohibited. An applicant found to be using AI during the interview process or while in preparation for an interview station/question will be reported to and reviewed by the Professionalism and Areas of Concern Committee and could result in your application being stopped on these grounds. If admitted to the program, identified breaches of this agreement will be addressed through MD program professionalism procedures.

The CoM will use your interview results in two ways. First, your interview results will be used for the purpose of evaluating you as an applicant to the CoM. Second, your interview results (with your identity removed) will be utilized for the purpose of assessing and improving our admissions procedures. You should be aware that, from time to time, research studies are employed to further our understanding of admissions to medical schools and to improve the way our society's future physicians are chosen. Any evaluations or research done on the interview processes which might include your de-identified interview results are for experimental purposes and, as such, are independent of how your interview results are used in the CoM's admissions processes.

Your failure to sign this agreement will result in the CoM withdrawing your application from further consideration.
