I began working in the UGME February 2, 2016, and realized soon after that I did not have the capacity or propensity to do my job without assistance for all things financial. Karen Amundson had been supporting the first year of Pre-Clerkship since November 2012 and did so with high proficiency. I approached Karen in July 2016 and proposed a new role for her in the UGME, supporting tracking of invoices and managing reconciliation for the UGME. Karen was eventually convinced to trial doing this work.

Karen's evolution from someone who managed the flow of funds rapidly evolved to the person that managed faculty contracts, the day to day and the preparation and submission of the annual UGME budget templates, tracks changes and budget requests all year long, provides monthly tracking and quarterly forecasting, is the expert on all things CONCUR, and in general resource for all staff, faculty, and students in relation to payment and/or reimbursement. In general – 'If you do not know, ask Karen. If Karen does not know, she finds the answer. The more complicated the issue, the harder Karen works to resolve it.'

Karen's knowledge and resourcefulness extends beyond the UGME. Karen is a source for departmental new and existing financial administrators and clerical staff, as well as deans' office financial staff and anyone else that used to work in the UGME. Karen is always game to help and provide information, willing to dig in to help fix someone else's oversight – she is the epitome of *collegial* and patient.

Karen is a great team member and quietly contributes to UGME activities and morale. If our coffee maker is broken, she has an extra one for the team to use. The UGME has cans and bottles to recycle and she takes them to Sarcan. Karen was admitted to RUH while she waited for surgery, and she requested a day pass so she can get her work done in the UGME. Karen gives *respect* and her knowledge, actions, treatment of others garners *respect*.

1. Collegiality:

Sue is a campus leader when it comes to collegiality. Within the Regina campus, Sue works closely with members of both the Pre-Clerkship and Clerkship teams, as well as campus leadership. Sue puts a lot of effort into building relationships with students so that they feel comfortable seeking support for a variety of issues.
