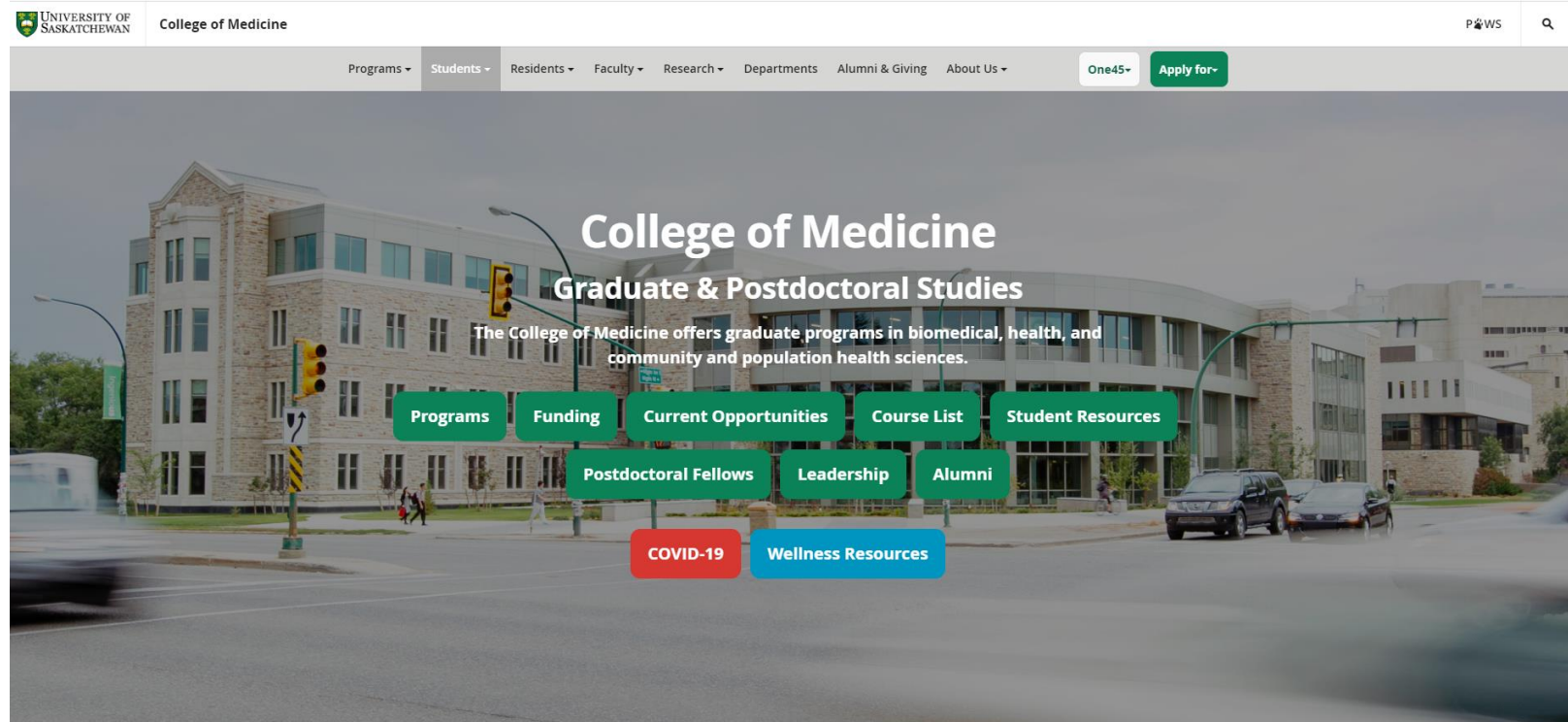

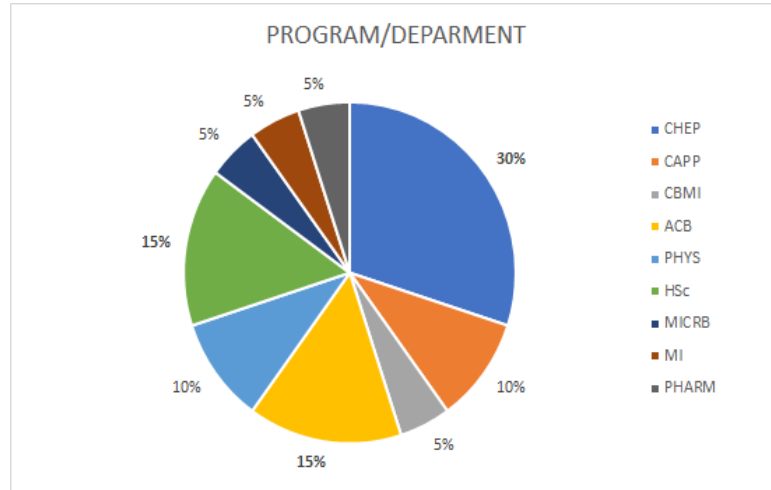


Figure 3: A pie chart showing the distribution of students in each program/department. The top three commonly stated programs have been highlighted

A bar graph of mental health stressors

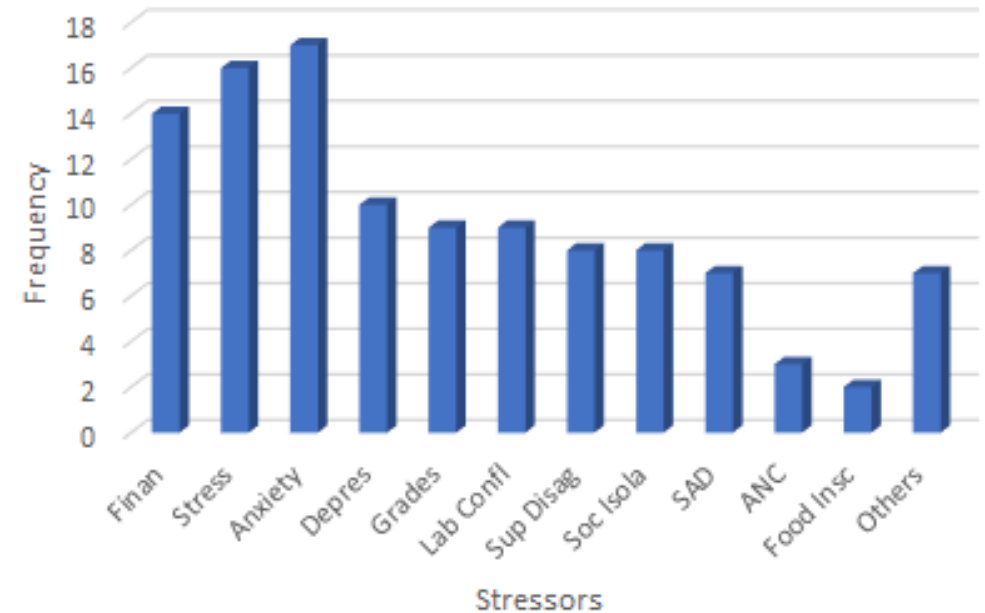


Figure 4: A bar showing the various mental health stressors among Graduate Students in the College of Medicine. Note: Financ = Finances, Depres = Depression, Lab Confl = Lab scheduling conflicts, Sup Disag = Supervisor disagreements, Soc Isola = Social isolation, SAD = Seasonal affective disorder, ANC = Adjusting to new culture, Food Insc = Food insecurity,

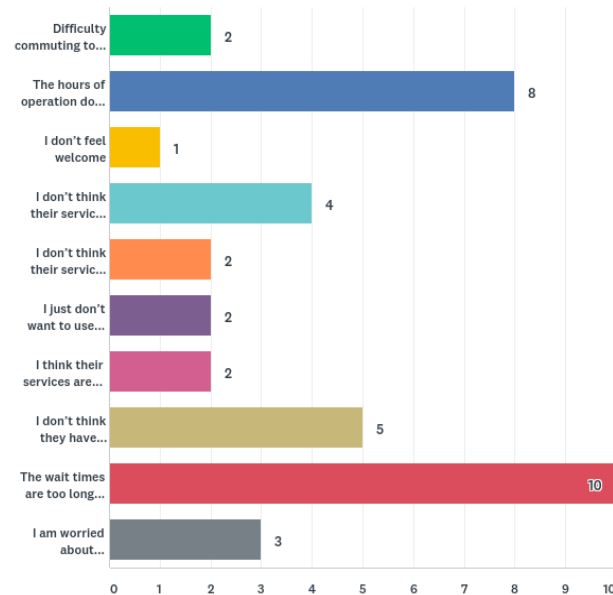

Q22 Which of these options would you find helpful if implemented for graduate students?

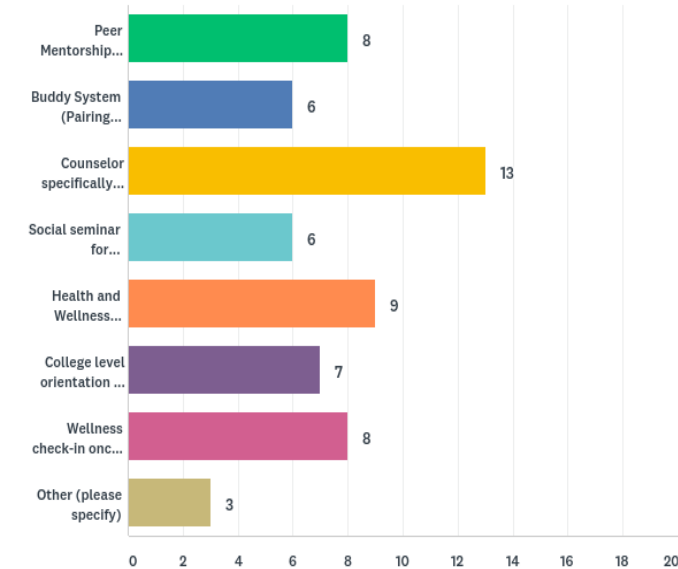

Recommendations

- ❖ Provide mental health training for supervisors
- ❖ Provide students hands-on skills workshops
- ❖ Allow flexibility in work/school schedules
- ❖ Create a safe environment for communication
- ❖ Create collaborative programs between students, departments, and mental health professionals
- ❖ Conduct qualitative studies on experiences of mental health among students

➤ Wellness Initiatives

- Student-Supervisor Agreement adoption across the CoM
- 990 Combined Seminar October 16 (*Dr. Murray Drew, from the College of Agriculture*)
- Mental Health First Aid Training (*offered to students, staff and faculty*)
- Emergency Medical/Compassionate Leave Grant
 - \$1000/month for up to two months
- Learner Wellness Coordinator (Mackenzie MacAuley)
 - Consolidation of Web resources from across campus

- Replaced (non-devolved) UGS
- CoM Devolved funds, GRF funds, CGPS devolved funds (starting this year)
 - ~\$88,000 was available in 2019-2020
 - 8 students funded
- Matching Scheme awards modeled after the CoMGRAD program
 - 60% Program: 40% Supervisor
- Targeting those students no longer eligible for CoMGRAD and Tricouncil support
 - *Early program “out of cycle” new recruits will only be considered if a surplus remains after the normal competition.*

➤ Stream Concept

Streams within the HSGP are intended to provide focus for areas of strength represented by critical mass of faculty, graduate courses and students. Streams are not formal programs recognized by CGPS and all programming must ultimately adhere to the HSGP umbrella under which they ultimately fall. Initially a Stream should be represented by at least 3 faculty and have relevant courses available or plans in place to develop relevant courses. Streams with five or more students will be invited to nominate a representative to the HSGP Program Committee.

➤ Stream Responsibilities

Ongoing commitment to ensuring relevant courses are available

- Including development of new courses

Providing necessary materials for the website

- Initially and then at least annually to maintain accuracy

➤ Key Recommendations:

- Enforce a Minimum Stipend – *done, required for non-professionally employed students*
- Create a part-time option – *CGPS: Not currently possible (tuition bursary was a first step)*
- Research days/symposia – *done*
- **Implement Streams** – *in progress*
 - A more close-knit environment for students working in a given area
 - Enhanced Community Building, Alumni Tracking, Outreach
 - An improved way to define faculty membership
 - A platform for curriculum development

➤ Opportunities:

- Additional Streams?
- Better Student/Alumni Tracking (Online bio-sketch, google docs, other?)

➤ Challenges:

- COVID-19 related disruption
- Budget uncertainty
- Potential tuition “reset” – University targeting median levels (tuition & Int. differentials)

Health Sciences Graduate Program Committee Terms of Reference

PURPOSE: The **Health Sciences Graduate Program Committee**, will provide leadership and advocacy on matters pertaining to the Health Sciences Graduate Program within the college of Medicine.

MEMBERSHIP:

- Graduate Program Chair (Assistant Dean Graduate Studies, College of Medicine)
- Five Faculty engaged in the supervision of students (either past or present) within the Health Sciences Program
 - Distributed to include units with major contributions to student supervision
 - School of Physical Therapy
 - Significant Clinical Departments of the College of Medicine
- Graduate student representative
- Grad Program Coordinator (non-voting)
- Others invited as required (non-voting)

Appendix: Program Committee TOR

TERMS OF REFERENCE:

Develop, implement, oversee, evaluate and refine a graduate education strategy for the Health Sciences Graduate Program.

Align this strategy with the University of Saskatchewan's policies for graduate and postdoctoral studies.

Evaluate and advise regarding graduate program curricula.

Develop graduate education processes that contribute to the mandate of the College of Medicine.

Review and recommend Health Sciences Graduate Program students for admission, graduate awards and scholarships.

Develop best-practice guidelines for MSc and PhD supervision, programs of studies and research advisory committees (RACs).

Develop processes and provide oversight and support for chairing of defenses, attending PhD committee meetings, chairing qualifying and comprehensive exams, chairing 990 seminars, conflict resolution, etc.

Advise College Senior Leadership regarding the resource needs of the Health Sciences Graduate Program.

Define and track indicators, metrics, and benchmarks to monitor and evaluate the ongoing and relative success and outcomes of the graduate program.

MEETINGS:

The Committee will meet approximately six times per academic year or by call of the Chair as required. The quorum must be 50% + 1 of the voting members.

REPORTING:

The Committee shall be accountable to the Vice Dean Research and shall provide advice and recommendations.

MINUTES:

The minutes will be taken according to the rules of the University Council.
