

# 2024-2025 Exemplary Resident Award

## **Purpose**

To recognize medical residents who serve as role models for others by successfully integrating Medical Expert and all intrinsic CanMEDS roles during residency education at the College of Medicine, University of Saskatchewan.

#### The Award

• One award (across all programs) is available on an annual basis.

# **Eligibility**

Any resident currently enrolled in a College of Medicine (RCPSC or CFPC) postgraduate residency program at the University of Saskatchewan.

## **Selection Criteria**

- Demonstrated excellence in Medical Expert role.
- Demonstrated role model behaviors in all six intrinsic CanMEDS roles.
- Integration of all seven CanMEDS roles in an exemplary manner, specifically demonstrating commitment to the profession, high standards of professionalism, life-long learning, excellent interpersonal skills, transformational leadership abilities and work-life balance.

#### **Nomination Process**

Each year the Postgraduate Medical Education Office issues a call for nominations. Department Heads, Program Directors, and Leaders in the College of Medicine are eligible to nominate a candidate. Self-nominations are ineligible.

Nominations are currently being accepted for the 2024-2025 Exemplary Resident Award. The deadline for nominations is May 30<sup>th</sup> 2025.

#### **Selection Process**

An ad hoc subcommittee of the Postgraduate Medical Education Committee will adjudicate the nominations. This committee includes the Postgraduate Medical Education Dean (or designate), three additional persons from among the central academic or administrative leadership of the College of Medicine, and a postgraduate resident representative.

# **Supporting Documentation**

**Each letter must address the selection criteria:** demonstrated excellence in CanMEDS roles; integration of all CanMEDS roles in an exemplary manner (refer to Selection Criteria section on previous page for complete information).

- Letter from nominator (must not exceed two pages).
- A minimum of one additional letter of support from any of the following groups: health
  professions learners, leaders of health care teams, leaders in Saskatchewan Health Authority,
  leaders in medical education, residency education administrative staff, RDoS, and external
  stakeholders e.g., SMA. Each letter of support must not exceed one page.
- Additional supporting evidence is required, e.g. resident assessments/ITERs; letters from peers, patients, stakeholder organizations, etc. Supporting documentation must not exceed two pages.

Department Heads, Program Directors, and Leaders in the College of Medicine are eligible to nominate a candidate. **Self-nominations are ineligible**.

Nominations must be submitted as a single PDF file with documents in the following order:

- 1. Nomination form
- 2. Letter from nominator
- 3. One or more additional letters of support
- 4. Additional supporting evidence

**NOTE:** All supporting documents must address the selection criteria. Incomplete/improperly formatted submissions will not be accepted.
