HIGHLIGHTS IN MEDICAL EDUCATION

An Innovation Identified as a Leading Practice and Innovation in the 2020 Accreditation Report of our Forensic Psychiatry Program

A meaningful collaboration in teaching Indigenous Mental Health and criminalization: An important step in the right direction.

Indigenous people are disproportionately represented in the Canadian criminal justice system. This is a well-known fact, which has been demonstrated by many academic studies in the past forty years. In 1988, a study done at the University of British Colombia by Michael Jackson found that in Saskatchewan, Indigenous people were between 6 and 7% of the population, but constituted 60% of admissions to provincial correctional centres (Jackson 1988, p216). Over-representation of people with mental illness including Indigenous people has also been increasing since late 1970s. This over-representation is often referred to as criminalization of mental illness. Forensic psychiatrists like other mental health professionals, patient advocacy organizations and policy makers are becoming more concerned about the number of indigenous people with mental illness in the criminal justice system, from the point of arrest through the courts and in incarcerated population.

Forensic Psychiatry is a branch of medicine concerned with the intersection of mental health and the legal system, in which scientific expertise and clinical expertise are applied to legal and administrative issues in contexts involving civil, criminal, correctional, or legislative matters. Forensic Psychiatrists also have specialized expertise in the assessment and treatment of special populations. (Forensic Psychiatry Competencies 2021 Version 1.0). **Read more...**

PGME PORTFOLIO UPDATES

Resident Well-being

The PGME Resident Resource Office (RRO) continues to demonstrate on-going commitment to resident well-being within our college. The past months have presented residents with new challenges within their educational environment and the PGME RRO is working continuously to ensure all resident needs are met. Over the past year we have collaborated with several organizations to foster well-being within our resident community:

The PGME RRO has collaborated with the National AFMC's Postgraduate Affairs Subcommittee, Saskatchewan Medical Association (SMA) and Resident Doctors of Saskatchewan (RDoS) during the Covid-19 pandemic to coordinate Mental Health resources, online support groups and access to virtual counselling services on demand. Rapid access protocols set up by the SMA Physician Health Program and the College of Medicine has allowed residents to have access to psychiatric care as needed. Digital Ice Cream Rounds and virtual town hall meetings with wellness focus have also been offered to the residents.

The PGME RRO has also collaborated with the Saskatchewan Health Authority – Occupational Health and Safety Office for a coordinated Covid-19 response and safety measures for residents.

The Covid-19 bursary to support medical residents had provided much needed financial support to learners in transition who had been negatively impacted by the pandemic. The CMA Foundation Covid-19 Support for Medical Learners Bursary provided support for 23 PGME residents at the College of Medicine.

The PGME RRO has collaborated with the Canadian Medical Protective Association (CMPA) in the implementation of Transition to Residency Curriculum - Resident Symposia Series at the University of Saskatchewan to close gaps in current educational offerings.

We are transitioning to Elentra from E-Portfolio

There is an ongoing need to review learner, program, and curriculum management. Acknowledging the co-existence of many platforms, the urgent need is to move from e-portfolio to Elentra.

This work will be completed in three phases and is being implemented through collaboration between PGME and IT systems (College of Medicine) and the implementation structure involves a Strategic Oversight and Implementation Committee, Management and Operations Committee, and Program-Level Operational Work Committees. Admissions: 2021 R1 Match

Due to COVID several key aspects of the match changed including electives and interviews. In December, the PGME office held a CaRMS workshop and a CASPER workshop for program directors and administrators to review all aspects of the match process. All interviews were virtual for the 2021 match cycle and the PGME office prepared a <u>virtual interview guide</u> for programs. In addition, COM IT met with program directors and administrators to assist them in preparing for all aspects of the virtual interviews. File review opened on February 8 and residency programs held interviews between March 8 and 28. First iteration match results will be released on April 20, 2021.

Medical students were not permitted to complete out of province electives so programs connected with applicants through virtual town halls and presentations. PGME provided funding for programs to collaborate with Media Production to create short promo videos to post on CaRMS program descriptions and program social media. Education

The PGME Resident Quality Referral and Consultation Education (QRCE)

QRCE was developed by the Saskatchewan Ministry of Health in collaboration with the College of Medicine PGME to train residents and physicians on how to improve the written and verbal referral/consultation communication. The Program is required for PGME completion and consists of four stages:

- An introductory presentation on effective consultation communication. This presentation provides data on the number of referrals made in Saskatchewan, the importance of good communication, and the impact of poorquality referrals and consultations on patients and on the broader health care system.
- Module 1 effective consultation communication in an acute care setting. This includes over the phone and inperson encounters such as a request for advice, investigations, or a transfer of care.
- **Module 2** make an effective written consultation. This module will cover the core elements of an effective written consultation and show how a written consultation can go wrong.
- A final interdisciplinary workshop- Case studies and evaluation of using the tools provided during residency.

A multi-level evaluation framework is being implemented including pilot testing, process evaluation and outcome evaluation. The introductory workshop was delivered to 120 PGY1 residents at the PGME Resident Boot Camp in June 2020. The two online modules or now available in Canvas.
